#### Surplus Food Outlook - Jan 2023 Update

1. Any details of previous offers of surplus food made by manufacturers/logistics companies which have had to be declined by FareShare due to storage issues?
  - a. Not an issue anymore. If it's food, we find a house for it. Bulk "Work-in-Progress" food from manufacturers isn't available as surplus at the moment.
  - b. FareShare UK are working heavily with Oaklands to repack and relabel food offers that are not currently in the correct format. (This includes Katsu Chicken, Quorn products, Cous Cous, Frozen Bread, etc)
  - c. If an offer gets rejected, it is one of the following - Non-food (Cups, Cutlery, Paper bags, etc), Drinks, Sachets of Mixed Sauce, Pet Food and out of date food that cannot be extended by us.
  
2. Further update about the Coronation Food Project – Are there any projections in terms of volumes or food types for 2024?
  - a. Additional details are not available at the moment. CFP food has started coming in, but the volume is very low via Alliance Manufacturing. Other CFP offers are not yet visible.
  - b. Hoping to get more projections during February, but hard to predict.
  
3. What is the outlook of surplus food for 2024, factoring in Harvests / Produce season – What will be available on CFM food orders? Plus any estimated timelines around this.
  - a. It appears to be a tough season for Produce. Some links below will provide greater insights.
  - b. There is a massive opportunity with frozen food and stock suitable for catering organisations. Many surplus food offers will be shifting toward this regard.
  - c. There are many offers of fresh and frozen bread and bakery. We could see an increase on this front as well.
  - d. Overall; pressure with limited dairy, ambient, plus produce at least until next harvest season.
  - e. Repurposing food for redistribution: Frozen veg from the FareShare FLEX project will be used to try and fill some of this gap. Frozen carrots mostly, plus other veg. So the more frozen food groups can take, the better availability there is for this.
